The animals received ante- and post-mortem health inspection at the abattoir by a Veterinary Medical Officer, USDA Food Safety and Inspection Services, and they were apparently free from infectious and contagious diseases and injuries parasites.

During the manufacturing process, the material was subjected to a pH of ≤5 and a temperature in excess of 65 °C for at least 3 hours and was not commingled with any other material of animal origin. Blood collection records are incorporated into the manufacturing batch documents.
